A large crushing plant within our yard also provides finished product that meets or exceeds Cal-Trans Class II ¾” base rock specifications.

Trucking and Heavy Hauling: A large fleet of 10 wheeler to semi-end dump trucks for hauling the demolition debris when needed and not dependent on another third party dispatcher allows Kroeker Inc. to heavy haul low-bed type units to get the equipment to and from the job site as required.

SPECIALITY EQUIPMENT

Hi-Reach Excavator - This machine weighs in excess of 140,000 lbs. and has a vertical reach of 82 feet, more than adequate to reach the top of a 5 story structure. A hydraulic shear or 6,000 lbs. hydraulic breaker attachment can be used at the machine's maximum height of 82 feet.

LaBounty UP 70 - This is a Hydraulic Universal Processor capable of crushing concrete structural walls and foundations up to 36" thick. It can be reconfigured to cut steel up to 1" thick such as steel tanks and structural steel members. This unit allows the crews the opportunity to selectively demolish and control the demolition environment.

LaBounty UP 30 - This is similar to the UP70 on a smaller scale. It also is attached to a Hydraulic Excavator at the end of the third member or stick portion of the unit which allows for more reach than the UP70. Concrete pulverizer and steel shears are standard also.

Concrete Breakers - Kroeker Inc. has a wide variety of sizes depending on the size of material to be broken. The largest is a 16,000 lb. breaker used on massive foundations and rock excavations. Kroeker also has 8000, 6000, 4000, and 2000 lb. breakers all attached to hydraulic excavators.

Mini Excavator - Kroeker Inc. has a robotic electric excavator equipped with a hydraulic breaker and shear used primarily on interior type renovations where access is restricted. This unit will travel through a 36" opening and reach 14' all while keeping the operator a safe distance from the work.
